Urgent call for help to all!

Our house (housing project for electrosensitive people) has been uninhabitable for us since Monday morning!

Dear electrosensitive people, dear interested parties!

In the last 3 years, since the announcement of the plan to erect two transmitter masts in our remote area, we have written around 100 letters to all the responsible authorities, describing our current situation (before a transmitter was switched on in our vicinity). This situation was already very borderline in terms of radiation exposure due to transmitters a few kilometers away. This means that even the slightest increase in radiation exposure would inevitably lead to a considerable worsening of our symptoms.

At this point, it is important to emphasize that:

- EU Resolution 1815, DOC 12608, has been calling for recognition, rights, protection and protected areas for us electrosensitive people since 2011.

- *Technology assessment, which has informed the Bundestag of the explosive nature of the situation of those affected.*

- EESC (European Economic and Social Committee)

- Official Journal C 105 of the EU that electrosensitivity has been recognized as a disease.

We made it very clear in these letters that switching on one of the transmitters would lead to at least one death within a very short time.

On Monday, August 5, 2024, we observed work being carried out on one of the transmitters. After inquiring with the workers, we learned that the switch-on was scheduled for August 9, 2024. In great concern and desperation, we contacted a well-informed lawyer on August 7, 2024. An urgent application was submitted to the Ansbach Administrative Court to prevent the switch-on. On Monday, August 12, 2024, we learned that this application had been rejected by the Ansbach Administrative Court despite the best explanations and certificate submissions.

On the same morning, the transmitter mast was switched on, which immediately led to the first severe physical symptoms in all the residents of the housing project. Using a measuring device, we were able to determine a thirty-fold increase in the previously measured values from the direction of the transmitter as a peak!

Despite shielding measures, our vital functions were so restricted after a short time that we had to flee from the house into the forest as quickly as possible. We spent the night there, but with little rest.

Unfortunately, one of our housemates is so severely affected by MCS and CFS/ME that it is not possible for her to move. So she had to stay in this radiation hell, enduring great pain, inflammation, nervous breakdowns and fear of death. She only just survived the first night. According to her, we forest refugees would not have survived that night.

We returned from the forest on Tuesday morning. The symptoms of the previous day immediately set in again - getting worse over time. We were only able to make quick phone calls, take a shower and prepare food before fleeing back into the forest. This deprived us of further normal activities. **Our house has been uninhabitable for us since then due to the effects of the radiation, we are effectively homeless. For various reasons, we have no alternative place to live, not even temporarily (mountain or forest hut or simil** Katja's short stay in the house caused painful trigeminal neuralgia due to the radiation exposure, which made it impossible for her to return to her own apartment even for a short time. I, Hartmut, also experienced similar neuralgia symptoms when I entered the house.

It is now Wednesday, August 14, 2024, 12:00 noon (letter created in the forest).

The application has been blocked by the Ansbach Administrative Court, and further steps have been initiated by our lawyer at the Munich Higher Administrative Court.

The operator (Telefonica) has also been informed about the overall situation since the year before last (also currently), as have (currently) the Federal Network Agency and the Federal Ministry for the Environment.

We are sending these descriptions today as a circular letter to affected persons, associations and other organizations.

We ask every recipient who has the opportunity to do so to spread our message further and also to intervene by email, letter or telephone contact (even if it is only 5 sentences) with the administrative offices listed below in order to achieve a remedy for our existential emergency situation!

We would be delighted if you could also include us in your prayers.
